## INVITATION OF QUOTATIONS FOR THE ISSUANCE OF PASSENGER TRANSPORT SERVICES PERMITS FOR THE INTER-PROVINCIAL PASSENGER TRANSPORT THROUGH THE SOUTHERN EXPRESSWAY

(TENDER NO. 26)

Quotations will be received by the National Transport Commission for the issuance of new Passenger Transport Services Permits for the inter-provincial Passenger Transport Services based on passenger surveys conducted on the Southern Expressway. Such service

operators having a valid passenger transport services permit on roads parallel to roads described in the schedule below (on roads that can give an impact) can only submit applications.

**All applicants should submit their applications subject to all the conditions stated below:**

- ❖ Separate applications should be submitted for each route.
- ❖ An applicant could apply only for three routes.
- ❖ Applicants could submit only one application for a single route.
- ❖ When tender applications are submitted by either a company or a business firm, its directors or shareholders cannot submit tender applications for a route individually. At the same time, when tender applications are submitted by either a company or a business firm and if such companies or business firms are having the same Directors or shareholder, also cannot submit separate applications for a route.
- ❖ Operators already having passenger transport permits for plying buses on the Southern Expressway cannot apply for these routes.
- ❖ Submission of incorrect information may result in rejecting applications.
- ❖ For Southern Expressway, only one passenger transport permit will be issued per applicant.
- ❖ Passenger service permits / temporary passenger service permits already issued will be cancelled with the issuance of new passenger permits.
- ❖ On occasions where applicants who have submitted applications for more than one route are selected, the bid having the maximum percentage above the technical value will be qualified to obtain the Passenger Transport Services Permit, for routes for which bids are submitted.
- ❖ The permits issued under this tender, unless cancelled in advance, will be effective for a period not less than one year, not more than three years or for a period of time as stated in the permit. As per the provisions in the National Transport Commission Act with regard to the services provided during that time and on a request made by the owner of the permit, the period of the said permit can be extended for a period not below one year and not above three years calculated from the Date of Expiry (as per Sections 25 and 30 of the National Transport Commission Act)

- ❖ Reservation of seats in the buses will solely be carried out by the National Transport Commission and bus owners who act contrary to this will have their permits cancelled.

**N.B.:** If a case is pending in Courts relevant to this, granting of tender will be carried out so as not to prejudice such legal proceedings.

The relevant time tables, fare tables and specifications of the buses with regard to the above services, are attached with the bid documents. Tender applications for these routes can be obtained from the National Transport Commission at No. 241, Park Road, Colombo 05 on payment of an amount of Rs. 3000/- per each application.

Tender applications will be issued from 04.05.2018 up to 23.05.2018 (both days inclusive) on working days, between 9.00 a.m. and 3.00 p.m. Tender applications issued by this commission should only be used to submit tender.

Applicants should deposit an amount of Rs. 200,000.00 as security bond and the Receipt thus received for crediting the amount to the Account of the National Transport Commission should be submitted to the Cashier of the NTC and obtain a Receipt before 9.30 a.m. on 24.05.2018. The receipt should be inserted in the 1st envelope along with the application.

Acceptance of applications relevant to this tender will be closed at 10.00 a.m. on 24.05.2018 and will be opened immediately thereafter at the Auditorium of the NTC. All the details required can be obtained either by visiting NTC or by Telephone No. 011-2553144.

The National Transport Commission retains the full right in either granting of tender or cancelling it. The National Transport Commission shall not be liable for any costs or expenses incurred by the applicants in this regard.
